 Category A: Education and Research relates to all cantonal universities, Swiss Federal Institutes of Technology, research institutes in the FIT sector, Fachhochschulen, public research institutes and teaching hospitals.

It comprises all organizations which, pursuant to the Law on Promotion of Higher Education, the Law on Research, and the Federal Law on Fachhochschulen, are supported by **public** subsidies.

It also includes organizations engaging **predominantly** in primary and pre-competition research.
